1. General. Before submitting a manuscript authors should ensure that the style and format complies with that of the journal. Manuscripts should only be submitted electronically (by e-mail). All editorial processing is done electronically.

2. Cover letter. All manuscripts must have an accompanying letter confirming that the material is original, has not been previously published and is not under consideration elsewhere. The note to the editors should explain the aims of the study and what is novel. The contributions of all co-authors to the study should be detailed.

3. Language. All manuscripts should be written in English. Authors whose native language is not English should have their manuscript edited and corrected for English grammar and style prior to submission. Please visit www.elsevier.com/locate/languagepolishing for more information. Manuscripts with poor English or those that do not conform to the format of the journal will be returned to the authors for correction.

4. Text. The text should be in a word processing format such as Word.doc. The text should be double-spaced and justified on the left side only. The text of experimental studies should follow a standard format with subdivisions (Title page, Abstract page with Keywords, Introduction, Materials and Methods, Results, Discussion, Acknowledgements, References, Legends to Figures, Tables). All experimental studies on humans or animals must include reference to the approval received from the appropriate Institutional Ethics Committee.

5. Title page. This should include the title of the manuscript, the full names of all authors, the affiliation institutes and addresses of all authors. The corresponding author should include contact details including: full postal address, telephone and fax numbers, and e-mail address. A short title (running head) of no more than 60 characters (including spaces) should be supplied.

6. Abstract. This should not exceed 200 words and should reflect the content of the manuscript. The abstract should consist of a single paragraph. It should not include references or abbreviations.

7. Keywords. Following the abstract up to seven keywords should be provided for indexing and database purposes. These should include the subject used in the study (animal, human, plant). Ensure the keywords are legitimate and appear in common bibliographic databases.

8. Introduction. This should be concise and include the pertinent background to the research and explain what is novel in the study and why the study was undertaken (the aims of the study).

9. Materials and methods. These should be presented in sufficient detail so that if other investigators want to repeat the study they can do so. Details of all instruments (model, manufacturers, town, state or country) and all chemicals must be provided. The experimental set-up must be detailed (animal species, gender, age, weight, source of animals, maintenance, experimental treatment etc.). Approval for the experimental protocols by the local Institutional Ethics Committee must be provided. All units of measurement must conform to standard SI units.

10. Results. These should present the findings of the study without interpretation or discussion. Results should be written in the past tense. Illustrations, graphs and tables should be presented separately and not embedded in the text.

11. Discussion. This should not repeat the results, but refer to the relevance of the results in the broader context of what is known and show how the study has advanced our knowledge of the topic. The discussion is not the place for a complete historical review, but should indicate what has been achieved in the present study.

12. References. These should conform to the current format for the journal. References in the text should be written as: (Jones, 2008; Jones and Smith, 2008; Jones et al., 2008; Jones et al., 2008a, 2008b). References in the list of references at the end of the paper should be written in the following style:

Articles in press should include the "doi" citation. It is strongly recommended checking all references for 100% accuracy using bibliographic databases such as PubMed. If you use a commercial reference software program such as Thomson Reuters EndNote® or Reference Manager®, ensure that the format selected complies with that of the journal.

13. Legends to figures. These must be sufficiently clear to a person just looking at the figure to understand what is represented without the need to refer to the main text. Do not refer to magnifications in the legends. It is permissible to provide the objective magnification.

14. Illustrations. All micrographs must have a linear scale bar. Micrographs should be presented in a digital image format (jpg, bmp, tif) or as a pdf file. Do not present images as Word.doc files. If possible group images in plates, rather than as separate images. Ensure that any overlays (arrows or letters) are sufficiently bold to be seen easily. Remember that in the printed version, the images may be considerably reduced in size. It is important that the file size of illustrations is sufficiently small to allow easy electronic transmission.

15. Color images. The online version of accepted papers will show illustrations in color (without charge). A page charge to be covered by the authors will be made if the color images in the printed version of the journal are to be printed in color (€ 250.00 for first color figure and € 200.00 for every subsequent figure). After acceptance, authors will be asked to confirm if they want their images in color in the printed version. Authors who agree to pay the production costs for figures to be published in color will automatically receive 50 additional free offprints.

16. Line-drawings should be submitted in a final format without overlays. Many software programs will not retain the position of the overlays during the editorial processing or typesetting. For further information about the preparation of electronic artwork, please see www.elsevier.com/artworkinstructions.

17. Tables. All tables should be presented as separate pages of text and should be numbered consecutively.

18. Abbreviations. Do not use abbreviations in the title. The first time an abbreviation is used in the text, it must be written in full. It is not recommended to use abbreviations if a word is not repeated many times. If there are a large number of abbreviations in the text, add a list of abbreviations (after the Keywords of the abstract page).

19. Referees. All manuscripts will be sent to referees for evaluation. The editors encourage authors in their cover letter to append a short list of potential referees, who have expertise in the specific subject matter of the manuscript. This may help speed up the editorial processing.

20. Acceptance. When a paper is accepted for publication, the publishers will send the corresponding author several forms to be completed including those dealing with copyright, reprints and color images. After typesetting, the corresponding author will receive page proofs for checking and approval. Shortly after these are checked, corrected, approved and returned, the paper will appear "online" with a doi reference (citation reference). This can be accessed via Science Direct at www.sciencedirect.com. The printed version with the final pagination will appear at a later date. There are no page charges.

21. Offprints. The corresponding author, at no cost, will be provided with a PDF file of the article. Additional paper offprints can be ordered by the authors. An order form with prices will be sent to the corresponding author.

22. Copyright. Submission of a manuscript implies that the manuscript has not been published before (apart from as part of a thesis or lecture, note, report or abstract) and that it is not under consideration for publication elsewhere. It also implies that the publication has the approval of all co-authors as well as the institution where the study has been performed. For more information see www.elsevier.com/authorsrights.

Funding body agreements and policies.
