Basic and Applied Ecology seeks reviews, perspectives and original contributions from all areas of basic and applied ecology. Ecologists from all countries are invited to publish ecological research of international interest on its pages. There is no bias with regard to taxon or geographical area. Basic and Applied Ecology is the official journal of the "Gesellschaft für Ökologie", the Ecological Society of Germany, Austria and Switzerland. The acceptance of a paper implies that it has been reviewed and recommended by at least two reviewers of which at least one is from the Editors or the Editorial Board.

**Copyright:** Once a paper is accepted, authors will be asked to transfer copyright (for more information on copyright, see http://www.elsevier.com/authorsrights). A form facilitating transfer of copyright will be provided after acceptance. If material from other copyrighted works is included, the author(s) must obtain written permission from the copyright owners and credit the source(s) in the article.

**Open Access.** This journal offers you the option of making your article freely available to all via the ScienceDirect platform. To prevent any conflict of interest, you can only make this choice after receiving notification that your article has been accepted for publication. The fee of \$3,000 excludes taxes and other potential author fees such as color charges. In some cases, institutions and funding bodies have entered into agreement with Elsevier to meet these fees on behalf of their authors. Details of these agreements are available at http://www.elsevier.com/fundingbodies. Authors of accepted articles, who wish to take advantage of this option, should complete and submit the order form (available at http://www.elsevier.com/locate/openaccessform.pdf). Decisions on peer review and publication itself will be quick. Authors will generally be notified of acceptance, rejection, or need for revision within ten weeks of receipt, but delays in obtaining reviews etc. may prolong that period.

We welcome offers to review books for Basic and Applied Ecology.

## **Preparation of Manuscripts**

From now on, all manuscripts should be submitted electronically through **Elsevier Editorial System (EES)** which can be accessed at: http://ees.elsevier.com/baae.

The submission letter should include the names, addresses and e-mail addresses of four potential referees. Type manuscripts double-spaced throughout and with wide margins. Number pages and lines consecutively. Type genus and species names in italics. Manuscripts should be as short as possible, but no longer than 4,500 words (including the complete text with references and legends, excluding tables and figures) and with titles of less than 15 words and abstracts of less than 300 words. Production of Basic and Applied Ecology is expensive and authors will be charged printing fees of  $\in 200/\ensuremath{\in} 300$  (Gf0E-members/non-members) per article. Remission of fees may be granted on application to authors without personal or institutional funding.

**Language:** Manuscripts should be written in English. Linguistic usage should be correct.

**Title page:** The title page should include the names of the authors, title of the paper, running title, number of words (altogether, title, abstract), address for correspondence, phone number, fax number, and e-mail address.

**Title:** The title should be short and informative and contain words useful for indexing.

**Abstract and key words:** The second page of the manuscript contains the abstract in which the main points are summarized. The English abstract should be followed by a German abstract. The German translation may be provided by the Editors. Immediately following the abstract, up to ten key words (excluding words used in the title) should be supplied indicating the scope of the paper.

**Introduction:** State the reason for doing the work, the hypotheses or theoretical predictions under consideration, and the essential background.

**Materials and Methods:** Provide sufficient details of the techniques to enable the work to be repeated.

**Results:** State the results drawing attention in the text to important details shown in tables and figures.

**Discussion:** Point out the significance of the results, and place the results in the context of other work.

**Acknowledgments:** These should be a brief statement at the end of the text and may include funding information.

References: In the text, references should be in chronological order and with the year in parentheses. In the first entry of each reference list up to five authors. When there are six or more authors, the sixth and subsequent authors are abbreviated as "et al.":
Pfadenhauer (1995), Pfadenhauer & Otte (1995), Gurnell, Petts, Hannah, Smith, Edwards et al. (2001). In the second and following attribute is professionally and the first authoris and and all the first authoris and all the first authorises.

Pfadenhauer (1995), Pfadenhauer & Otte (1995), Gurnell, Petts, Hannah, Smith, Edwards et al. (2001). In the second and following entries of the same reference, only the first author is named and all co-authors are abbreviated as "et al.". Avoid excessive citations; cite only essential resources.

In the list, references should be arranged first alphabetically and then further sorted chronologically if necessary. More than one reference from the same author(s) in the same year must be identi-fied by the letters "a", "b", "c", etc. after the year of publication.

**Tables:** Each table should be numbered, placed on a separate page, and accompanied by a title at the top.

**Figure Legends:** Figure Legends should be grouped and placed on a separate page. Legends should be sufficiently detailed to enable the reader to understand the figure without reference to the text.

Illustrations: The maximum type area is 16.6 cm width and 23.6 cm height. Figures should be designed to fit either one-column size (8.0 cm) or two-columns size (16.6 cm) in width. Figures must be ready for reproduction with clear lettering in suitable size. In figures that consist of more than one part, the single parts are to be named with capital letters in round brackets. Please stick to this scheme in the Legends. Figures should be supplied in digital format (EPS or TIFF format, final resolution 300 dpi for halftones, 1200 dpi for black/white line drawings).

Colour figures can be printed only if part of the costs are covered by the author. The author will be informed about the cost after submitting the manuscript. Label each figure with authors' names and figure number. The same data should not be presented in both graph and table form. Figures and tables should be self explanatory.
