## Instructions to Authors

The Journal publishes papers from the following areas of immunology:

- Clinical Immunology & Allergy
- Innate Immunity
- Tumour Immunology
- Adaptive Immunity
- Immunopathology
- Immunogenetics
- Parasite Immunology
- Immunochemistry

The Journal considers for publication original research papers. In exceptional cases we aim to publish high priority papers of special importance on-line within 4–6 weeks of submission. On occasion, the Journal will publish reviews, editorials and letters to the editor. Reviews should be solicited by the editors. Editorials are primarily contributed by the editors but may also be accepted from authors not associated with the Journal. Letters to the editor should deal with matters of urgent scientific interest and should be very brief.

**Copyright 1.** An author, when quoting from someone else's work or when considering reproducing an illustration or table from a book or journal article, should make sure that he is not infringing a copyright. **2.** Although in general an author may quote from other published works, he should obtain permission from the holder of the copyright if he wishes to make substantial extracts or to reproduce tables, plates, or other illustrations. If the copyright holder is not the author of the quoted or reproduced material, it is recommended that the permission of the author should also be sought. **3.** Material in unpublished letters and manuscripts is also protected and must not be published unless permission has been obtained. **4.** A suitable acknowledgement of any borrowed material must always be made.

**Manuscripts** should be written in English, double-spaced and divided into the following sections: Abstract, Introduction, Materials and Methods, Results, Discussion, Acknowledgements, References and Figure legends. The title page must comprise the title, a short title to be used as a running head (not exceeding 50 characters), the name(s) of the author(s), address(es), an address for correspondence, 5–7 keywords (in alphabetical order), and a list of abbreviations used in the paper.

**References** should be cited in the text by first author name and year (Surname, Year) and listed alphabetically in the references section, for example:

The author is fully responsible for the accuracy of bibliographic references.

**Figures** should be sent as eps, tiff, pdf or MS office files at a minimum resolution of 300 dpi for halftones and 600 to 1200 dpi for black/white line drawings. Please ensure figures are of an appropriate size and dimension. Colour figures should be encoded as RGB. Figure legends should contain sufficient detail to be understood without reference to the text. If, together with your accepted article, you submit usable colour figures then Elsevier will ensure, at no additional charge, that these figures will appear in colour on the web (e.g., ScienceDirect and other sites) regardless of whether or not these illustrations are reproduced in colour in the printed version.

**Electronic submission** Manuscripts should be submitted electronically through the **Elsevier Editorial System (EES)**, which can be accessed at <http://ees.elsevier.com/imbio>.

**Fast-track submission** In exceptional cases papers of outstanding quality and promise deserving rapid publication may be sent direct to a section editor for review. The aim is to publish these high priority papers online within 4–6 weeks of submission. Please indicate in your cover letter/e-mail that you are submitting a fast-track paper direct to the section editor.

**Proofs and reprints/PDF** will be sent to the author named for correspondence. Only galley proofs are sent to the authors. No page charges or handling fees are required. The corresponding author, at no cost, will be provided with a PDF file of the article via e-mail. The PDF file is a watermarked version of the published article and includes a cover sheet with the journal cover image and a disclaimer outlining the terms and conditions of use. Additional paper offprints can be ordered by the authors. An order form with prices will be sent to the corresponding author.
